THE LAST WILL AND TESTAMENT OF EDWARD ANDREWS SEN.^R --

In the name of God. amen. I Edward Andrews Sen.^R of the District of Fairfield and State of South Carolina. being Sick, but of Sound and disposing memory & mind Considering the Certainty of Death, & the uncertainty of the time thereof, & being desirous to Settle my Worldly affairs, & thereby be the better prepared to leave this world, whin it Shal please God, to Call me hence. Do therefore publish this my last Will & Testament, in manner and form following VIZ. --

1st I Commit my Soul to God and my boddy to the Earth, to be decently Buried at the Discretion of my Executors herinafter Mentioned, & named, after my Debts & Funeral Expence are paid 2^d-- It is my will to Give and bequeath to the heirs of the boddy of my daughier Martha Gibson Late Wife of Stephen Gibson, One Negroe Boy named Peter, hereby empowering my Executors and Other Heirs, at The apraisement of the apraisers of my Estate, to keep the above mentioned Negroe peter and any Other negroes belonging to my Estate that may fall to the Heirs of my Said Daughter Martha. & pay them the vallue as Soon as they may Severally arive to the age of Twenty one Years , or marry,

3^d I will and bequeath to my Daughter Elizabeth Gibson. Wife of Abel Gibson. and the Heirs of her boddy forever, one Negroe boy named. Supeter--

4th I also Will & bequeath to my Daughter Patience Freeman

& to the Heirs of her boddy forever, one Negroe Boy named Ephraim & one Hundred Acres of Land out of my Estate where She now lives--

5th -- I also. Will & bequeath to my Daughter Nancy Wells, & The heirs of hir Boddy forever, one Negroe Girl named Becky, together with her future Ishue --

6th-- I also Will to my Son James Andrews, one Negroe Man Named Isaac, to him & his heirs forever-----

7th-- I Give & bequeath to my Daughter Sharlott Ashford & The Heirs of her Boddy forever One Negroe Boy named Jefse,-

8th I also Will and bequeath to my Daughter Cynthia Kinnady & the heirs of her boddy forever. One Negroe Boy Named Ben-

jamin-- 9th I Will & bequeath to my Daughter Lucretia Kinnady & to the heirs of hir boddy forever One Negroe Girl named Winny- & hir future Ifshue=

10th I also Will & bequeath to my Daughter Mary an Disiker & to the heirs of hir boddy forever, one negroe Girl named Dark & hir future Ifshue ----

11th And I also Will & bequeath to my Son Edward Andrews, & his Heirs forever, one negroe man named Charles, one Horse his Choice of what I may be possed of at my death, Two Cows, and Calfs, Two Sows & pigs, one Bed bed Sted and Its furni-

ture, one Sett of Birch Tables- I have at the Request of my Son Edward laid of Two hundred and Eighty Seven acres of land ~~with~~ ~~he~~ ~~may~~ ~~choose~~ ~~of~~ ~~any~~ ~~kind~~ ~~of~~ ~~land~~ ~~of~~ ~~the~~ ~~kind~~ ~~I~~ ~~may~~ ~~be~~ ~~pos-~~ or what his pat Calls For, For which I have made him a title ~~of~~ ~~of~~ ~~at~~ ~~my~~ ~~death~~, ~~except~~ ~~that~~ ~~designated~~ ~~for~~ ~~my~~ ~~Daughter~~

~~Elizabeth Kinnady~~, and it is my will that my old negroe Woman. Winny. Should Stay as long as She Lives, on my Plantation or the part, my Son Edward. Chooses, as his property under h his Care & direction as long^{as} She lives- and further, it is

my will that all the Remainder of my Estate, Real & personal, not herein Specially Willed, to be Equally divided amongst all my Children, VIZ I think I have Remaining Enough of Negroes to divide one more to Each of my Children. Some of them Valuable & others not so much So and it is my will that Each Child Should have Equal Value in them, if they Cannot be divided Equally They must be Sold & the proceeds Equally Divided, and their will be a ballance of Land over what I have Willed, it is my wish that it may be Sold by my Executors, as Soon after my death, as may be Convenient & the precedes Equally divided among my Children, & my Executors is hereby fully authorised & impowered to make a title or titles to to the purchaser or purchasers, of Said Lands. Willed or Sold, And I do hereby nominate Constitute & appoint, my Son James Andrews. & my Son inlaw Samuel Kinnady or the Survivor of them Executors or Executor of This my last will and Testament. Hereby Revoking and making null & Void Every other former Will^{or Wills} by me heretofore made, Ratifying and Confirming This and no Other to be my last will and Testament. -- IN Witnefs whereof I have hereunto Set my hand and Seal. This Twenty Ninth day of Dec^r in the year of our Lord one Thousand Eight hundred & Twenty Six, and in the 51st year of the independance of the United States of America-- 2^d 3&4 lines Erased and interlined was done before Signing -----
